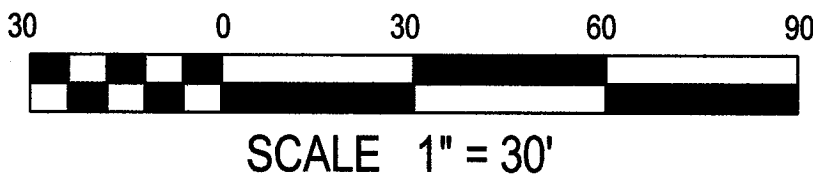
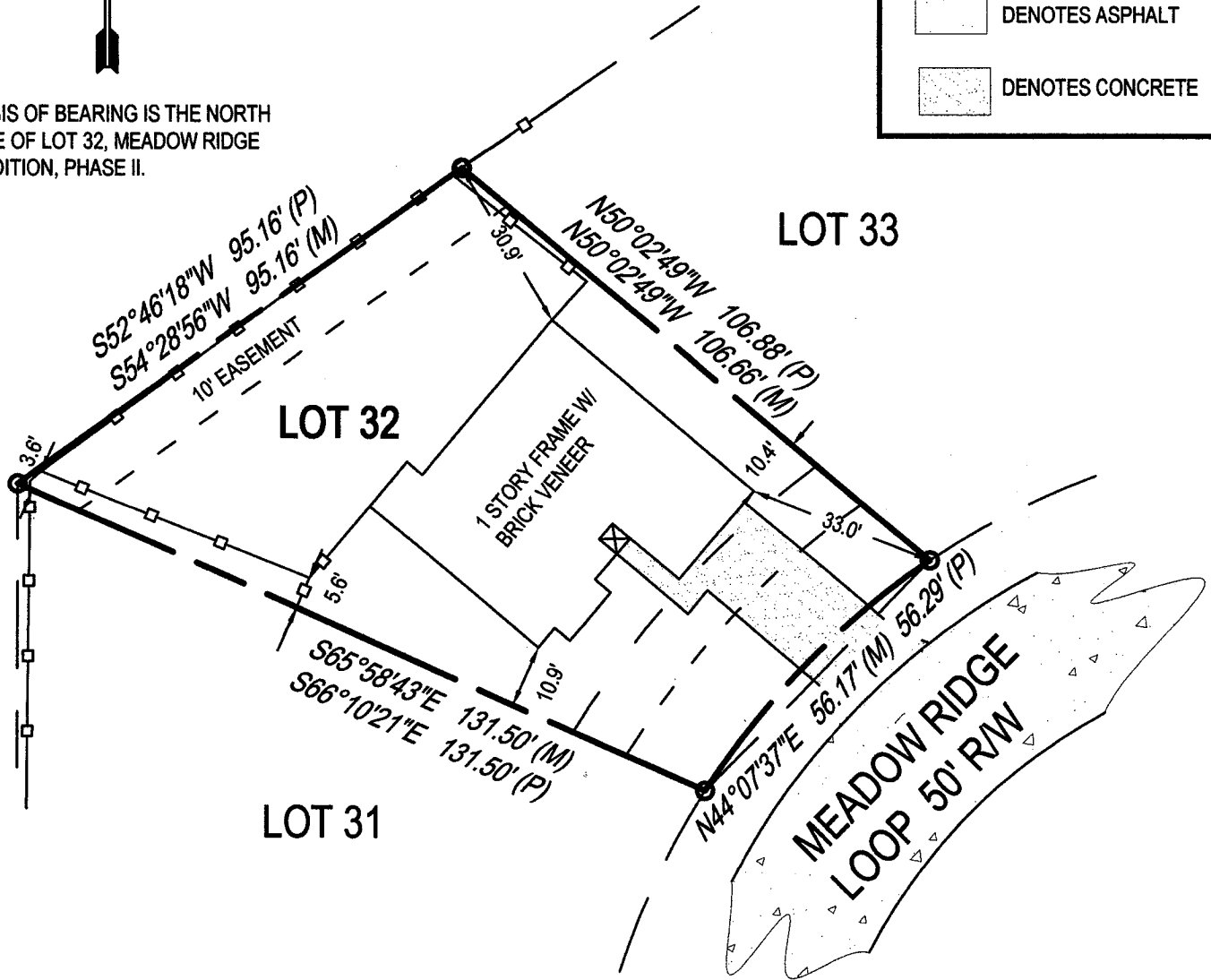




BASIS OF BEARING IS THE NORTH LINE OF LOT 32, MEADOW RIDGE ADDITION, PHASE II.
